Without limiting the generality of the foregoing, I further release any and all recourse, which I may now or hereafter have resulting from any decisions of the AFA. In addition, to the foregoing, I further waive any claims I may have in connection with cancellation or rescheduling of the event for whatever reason. The hosting AFA club reserves the right to retain all or part of the registration fees in the event of cancellation by either party. I declare that my physical condition, to the best of my knowledge, is adequate to participate safely in this event and that no physician or other qualified individual has advised me against participating in such an event. I further state that I am fully aware of any and all dangers and risks associated with Fencing and that I accept these dangers and risks.

Without limiting the generality of the foregoing, I also understand and agree that the Canadian Fencing Federation (CFF) Rules and Regulations require me to wear complete regulation fencing clothing (mask, protective jacket, breeches, plastron, glove with gauntlet) at all stages of the fencing event and that if the event is an Elite Circuit Event, that I must wear FIE approved equipment in accordance with the current Rules & Regulations as set by the CFF.
